

PRIVACY POLICY

Present Politics of confidentiality of personal data (further there is Politics) acts with regard to all information located on the website in the Internet to the address: CoinCash.cc (further there is Site), which users can locate during Site use, his services, programs and products. Use of Site services means User's unconditional consent with present Politics and the conditions of processing specified in it of his personal information; in the case of disagreement with these conditions User should abstain from services use.

1. GENERAL PROVISIONS

1.1. Within present Politics under User's personal information they are understood:

1.1.1. Any personal information which User grants of himself independently during Services use, including User's personal data. Information compulsory for granting of Services is labelled by special image. Other information is granted by User to his discretion.

1.1.2. The data which automatically are transmitted to services of the Site during their use with the aid of User of software installed on the device, including IP-address, the data of files cookies, information of the browser of User (or other program, with the aid of which it is provided access to services), performances of the equipment and software used by User, date and the time of access to services, the addresses of asked pages and other similar information.

1.2. Present confidentiality Politics is applied only to the Site. The site does not control and does not bear responsibility for the sites of third parties, to which User can proceed on references, accessible on the Site.

1.3. The operator of personal data for present Politics is online-service CoinCash.cc.

2. THE PURPOSES OF PROCESSING OF PERSONAL INFORMATION BY USERS

2.1. Site collects and stores only that personal information which is needed for granting of services or executions of agreements and contracts with User, except when by the legislation compulsory storage of personal information during term determined by the law is provided.

2.2. The Site processes User's personal information in following purposes:

2.2.1. Establishing with User of feedback, including the direction of notices, enquiries concerning use of the Site, rendering of services, demand processing and bids from User.

2.2.2. Receipt by User of urgent information of events and activities of online-service CoinCash.cc;

2.2.3. Grants to User of effective клиентской and technical support at occurrence of problems connected with using the Site.

3. THE CONDITIONS OF PROCESSING OF PERSONAL INFORMATION OF USERS AND HER TRANSFER TO THIRD PARTIES

3.1. Confidentiality is preserved with regard to User's personal information, besides the cases of voluntary granting by User of the information of itself for common access to unlimited circle of persons. With the use of separate services, User agrees that determined part of his personal information becomes popular.

3.2. Operator it is of the right to pass a personal information of User to third parties in following cases:

3.2.1. The user expressed consent to such actions.

3.2.2. Transfer is needed for use by User of determined service or for execution of determined agreement or contract with User.

3.2.3. Transfer is provided by the legislation within procedure installed by the legislation.

3.3. Processing of User's personal data is implemented without term limitation by any legal way, including in information systems of personal data with use of the means of automation or without use of such means. Processing and storage of personal given Users is implemented in conformity c by the law "Of personal data".

3.4. The operator takes necessary organizational and technical measures for protection User's personal information from wrongful or random access, destruction, change, blocking, copying, dissemination, as well as from other wrongful actions of third parties.

4. THE COMMITMENTS OF THE PARTIES

4.1. User is obliged:

4.1.1. To supply information of personal data, needed for use of Site.

4.1.2. To update, to complement given information of personal data in the case of change of given information.

4.2. The operator is obliged:

4.2.1. To use received information only for purposes specified in present confidentiality Politics.

4.2.2. To provide storage of confidential information secretly, not to publicize without preliminary written permission of User, nor to sell, exchange, publishing or publicizing by other possible ways User's transferred personal data, with the exception of provided by present confidentiality Politics.

4.2.3. To take measures of precaution for protection of confidentiality of User's personal data according to order usually used for protection of such information in existing business turnover.

4.2.4. To carry out blocking of personal data related to the appropriate User, since reference either User's enquiry, or his legal representative or authorized unit on protection of right of the subjects of personal data during check in the case of revealing of doubtful personal given or wrongful actions.

5. THE PARTIES RESPONSIBILITY

5.1. Administration of the Site which did not execute its commitments, bears responsibility for losses suffered by User in connection with wrongful use of personal data, pursuant to legislation.

5.2. In the case of loss or publicizing of confidential information the Site Administration does not bear responsibility, if given confidential information:

5.2.1. Became a public property or was received by third parties up to the moment of her receipt by the Site Administration;

5.2.2. Became a public property or was received by third parties on reasons, not dependent from Site Administration;

5.2.3. Was disclosed from User's consent.

6. PERMISSION DISPUTES

6.1. Before reference to court with is required on disputes arising from attitudes between Site User and Site Administration, compulsory is making a complaint (written proposal of voluntary adjustment of dispute).

6.2. The recipient of the claim during 30 (thirty) calendar days from the date of receipt of the claim in written form notifies the applicant of the claim of results of consideration of the claim.

6.3. At not arranging a settlement dispute will be transferred to consideration to court pursuant to current legislation.

6.4. To present Politics of confidentiality and attitudes between User and Site Administration current legislation of your country is applied.

7. ADDITIONAL CONDITIONS

7.1. Operator it is of the right to make changes to present Politics of confidentiality without User's consent.

7.2. New confidentiality Politics inures since her placement on the Site, if other is not provided by a new editing of Privacy Policy.
